

# Terms of Service – FinBot

## 1. Introduction

These Terms of Service (“Terms”) govern your use of the FinBot Discord bot (“FinBot”, “the Bot”, “we”, “our”, or “us”). By adding FinBot to your Discord server or using any of its features, you agree to these Terms, as well as [Discord's Developer Terms of Service](#) and [Developer Policy](#).

## 2. Description of the Bot

FinBot is a Discord bot designed to:

- Log symbolic “tributes” between members within a server (no actual currency is exchanged),
  - Track tribute activity and generate public leaderboards,
  - Automatically post tribute announcements to users’ connected Twitter and Telegram accounts using credentials they provide,
  - Support custom tweet graphics and personalized nicknames for shoutouts.

## 3. User Eligibility & Responsibility

By using FinBot, you confirm that:

- You are at least 18 years old or the minimum age of consent in your country.
- You have the necessary rights or permissions to authorize FinBot to post on your behalf to Twitter or Telegram.
- You understand that tributes are symbolic and for entertainment, community engagement, or roleplay purposes only.

You must:

- Not use FinBot for harassment, impersonation, spam, or illegal activities,
  - Not submit any unauthorized credentials or data that belongs to others,
  - Ensure that any content posted via your Twitter/Telegram accounts using FinBot complies with those platforms' policies.

## **4. Use of Submitted Content**

FinBot stores and uses submitted information solely to:

- Track tribute activity between Discord users,
- Post automatic tribute announcements,
- Generate leaderboard rankings,
- Include custom nicknames and visuals in tribute messages, if provided.

We do not claim ownership of your content or credentials. You grant us a limited, non-exclusive license to process your submitted data solely to deliver these services.

## **5. Termination**

We reserve the right to remove FinBot from any server or suspend individual access if:

- These Terms are violated,
  - There is misuse or abuse of the tribute system,
  - Required third-party services (Twitter, Telegram, Discord) revoke access or change policies.
- 

## **6. Service Availability**

FinBot is provided “as is” and “as available.” We may change features, restrict access, or shut down the service at any time without prior notice.

## **7. Disclaimer & Limitation of Liability**

We provide FinBot without any warranties of any kind. We are not liable for:

- Loss of access due to third-party API restrictions (e.g., Twitter/Telegram downtime),
- Incorrect or unintended postings,
- Unauthorized access caused by user negligence,
- Data loss due to bugs or server outages.
